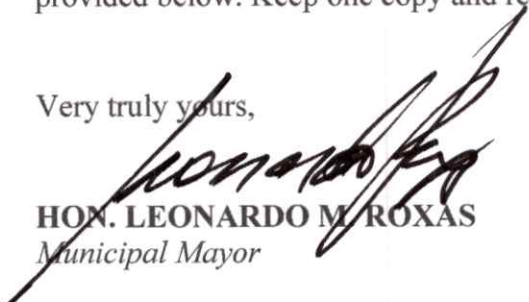

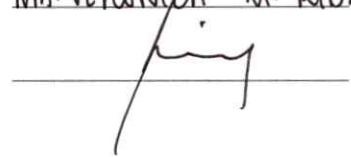

CONTRACT OF AGREEMENT

THIS AGREEMENT, made this _____ day of _____ **2024** between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **GREGMAN'S SPORTS** of 7065 7th St., Fairlane Subd., Brgy. San Vicente, Tarlac City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of Uniforms, MSWD Office (PYAP, SK Federation, Organized Women, BNS, PWD, LGBTQ Community, CDW, SC Presidents, ERPAT Presidents), LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Three Hundred Thirteen Thousand Six Hundred Pesos Only (Php 313,600.00)** by the Contractor for the execution and completion of such Works with the contract duration of Thirty (30) Days.

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

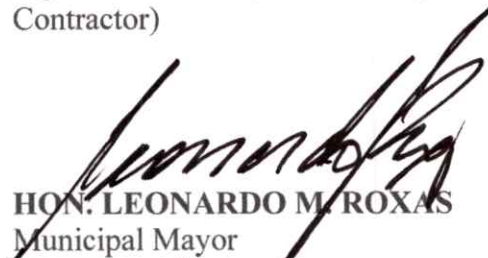
