THIS AGREEMENT, made this _____ day of _____ between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and HEPTAGON OFFICE SUPPLIES AND EQUIPMENT TRADING of #600 Brgy. Balayang, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of various Office Supplies to be used by various offices (1st Qtr 2025), LGU-Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Nine Hundred Thirteen Thousand Three Hundred Seventy Two Pesos Only (Php 913,372.00) by the Contractor for the execution and completion of such Works with the contract duration of Fourteen (14) days.*
