CONTRACT OF AGREEMENT

THIS AGREEMENT, made this _____ day of _____ between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and CUADRA'S EVENT CATERING SERVICES of San Fernando, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Supply & Delivery of Meals and Snacks of Activities and Programs of MSWD Office for C.Y. 2025 (hereinafter called the "Works") and the Entity has accepted the Bid for Two Million Six Hundred Eighty Thousand Seven Hundred Sixty Pesos Only (Php 2,680,760.00) by the Contractor for the execution and completion of such Works with the contract duration of Three Hundred Twenty (321) Days.

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
