WHEREAS, in response to the said advertisements, One (1) contractor submitted letter of intent and applications for eligibility;


WHEREAS, One (1) bid document were submitted on February 5, 2025 and both the bidder passed the eligibility & technical proposal;

CONTRACT OF AGREEMENT

THIS AGREEMENT, made this _____ day of 13 FEB 2025 between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **TOYO CONSTRUCTION BUILDER & SERVICES** of Barangay Samput, Paniqui, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Construction of Drainage Canal (Phase II) at Sitio Basio going to Caturay, Pob. Norte, Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Nine Million Nine Hundred Ninety Three Thousand Twenty Seven & 19/100 Pesos (Php 9,993,027.19)** by the Contractor for the execution and completion of such Works with a contract duration of Two Hundred Seventy (270) Days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
