CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 21th day of March 2025 between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and CEF PHARMACY of Brgy. Samput, Paniqui, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Supply and Delivery of various Laboratory Reagents at the Paniqui General Hospital, Brgy. Samput, Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Nine Hundred Seventy Five Thousand Pesos Only (Php 975,000.00) by the Contractor for the execution and completion of such Works with the contract duration of Seven (7) days.
